# LIMITED WARRANTY:

Products manufactured or rebuilt by Vanguard Technology, Inc. are warranted to be free from defects in material and workmanship, when installed, maintained, and certified in accordance with Vanguard's instructions and policies and in normal use and service for the time periods, terms and conditions as set forth below:

- 1) For a period of **One Year** from date of installation, but no longer than 18 months from factory shipment of new units, Vanguard will, at its sole discretion, repair or replace defective parts, assemblies or entire units, including labor costs of its authorized service agency. In the case of rebuilt units, all parts and assemblies replaced as part of the rebuild shall carry this same warranty. Travel expense of Vanguard's authorized service agent will be paid for the first ninety (90) days of this period, not to exceed sixty (60) miles or two (2) hours. This warranty may be extended to 2 years from installation date for an additional charge and must be confirmed in writing by Vanguard Technology, Inc. and must reference paid Invoice/Purchase Order and certified authorized agency Start-up. The heat exchanger and S. S. accumulator warranty remain as detailed here. All other warranty terms remain as detailed here.
- 2) For an additional <u>Four Years</u> from the date of original manufacture, Vanguard warrants the fin tube heat exchanger in the PowerMax<sup>TM</sup> Gas Booster to be free from defects in material or workmanship. At Vanguard Technology's sole discretion and in accordance with this warranty, defective heat exchangers will be replaced on a pro-rated and parts only basis. i.e. Owner will pay a percentage of the current list price of a replacement heat exchanger as follows: Failure within first year, no charge: within second year, 20%; within third year, 40%; within fourth year, 60%; within fifth year 80%.
- 3) The stainless steel accumulator is covered by a limited lifetime warranty and is warranted to be free from leaks for this time. Any attached gauges; controls or other parts are subject to the standard one-year parts and labor warranty.

This warranty is limited to the foregoing and does not apply to defect or malfunction resulting from or caused by installation, operation or maintenance not in accordance with manufacturer's instructions, damage related to shipping, accident, abuse, fire, flood, or other acts of God; units operated in corrosive or other damaging atmospheres or at temperatures outside specified operating range;

damage caused by freezing, improper water conditions (excessively acidic or alkaline water, excessive water pressure (over 65 psi), chemical contamination, sediment build-up, etc.), incorrect electrical supply or connection, insufficient combustion air or negative draft, insufficient water supply, stray current or voltage conducted through water piping or electrical wiring, excessive or insufficient gas pressure or volume, use of any steel, plated steel, or any cast iron parts, including pumps, in the installation or repair of the PowerMax<sup>TM</sup>; damage caused by any unauthorized alteration shall in no way be covered under this warranty. Cleaning of filters, pumps, valves, burners, fans or electrical connections, tightening of threaded connections, maintenance lubrication of any parts, and/or adjustment or calibration of controls is considered a part of normal installation and/or maintenance and is not covered under this warranty. Any damage caused by any of the foregoing will not be repaired under this warranty. Hot surface igniters are considered a consumable item, similar to a spark plug, and are not generally considered a warranty item. Accessory components sold but not installed by Vanguard are covered by a one-year parts-only warranty. Warranty on replaced parts or assemblies shall be the lesser of 90 days or the unexpired portion of the original warranty. Factory reconditioned and tested parts may be used to satisfy claims under this warranty. Warranty work shall be done only by Vanguard Technology's authorized service agency during normal working hours and must be authorized by telephone before work commences. Overtime labor will not be paid under this warranty.

There are no other expressed or implied warranties of any kind, including but not limited to any implied warranty of merchantability or fitness for any particular purpose or usage. The remedies under this warranty as set forth here-in are at the exclusion of all others and Vanguard Technology, Inc., neither assumes nor authorizes anyone to assume for it any other obligations. In no event shall Vanguard Technology, Inc. be liable for any remote or consequential damage of any nature, no matter how arising or from any cause whatsoever, or any amounts in excess of the selling price of the product. #### PRICES:

#### **QUOTATIONS:**

Unless otherwise stated, quotations are effective for 30 days from date issued.

#### **ACCEPTANCE:**

All orders are subject to acceptance by Vanguard Technology, Inc. headquarters in Eugene, Oregon. Possession of the Product Directory and Price List is not an offer to sell.

### **MINIMUM ORDER:**

A \$20.00 handling fee will be added to any invoice of \$50.00 or less.

## **CUSTOM ORDERS:**

Custom orders must be paid in advance and are not subject to cancellation.

### **PAYMENT TERMS:**

Payment should be included with all orders unless credit terms have been arranged. To establish credit, a credit application must be completed, signed and returned with banking and trade references. A recent financial statement may be required. Normal payment terms are **Net 10** days from shipment unless noted otherwise by Vanguard in writing. Payment may also be made by approved credit card with an additional 3% processing fee.

#### SHIPMENTS:
